Terrorism & Homeland Security

Deputy Commissioner John Miller, NYPD

John Miller is the Deputy Commissioner of Intelligence & Counterterrorism of the NYPD. He is the former Associate Deputy Director of National Intelligence for Analytic Transformation and Technology. Prior to that, he was an Assistant Director of Public Affairs for the FBI, where he was the bureau's national spokesman. Miller is also a former ABC News reporter and anchorman, perhaps best known for conducting a May 1998 interview with Osama bin Laden in Afghanistan. Miller's journalistic awards include two Peabody Awards, a DuPont-Columbia Award, and nine Emmys. He is a member of the International Association of Bomb Technicians and Investigators and the International Association of Chiefs of Police. Miller is an instructor at the FBI's National Executive Institute, as well as the Leadership in Counterterrorism course and has attended training in organizational change at Harvard University's John F. Kennedy School of Government as well as the Kellogg School of Management at Northwestern University.
